

Terms of Purchase

1. The optional Customer Monthly Subscription is a monthly standing order. You may designate the day of each month that you want your credit card charged. If you do not designate a day of the month, your credit card will automatically be charged each month on or about the day of the month specified on the front of this Order Form.

2. The Customer Monthly Subscription includes: (1) a minimum per month order; (2) an online contact manager wherein you can store the names and information of your contacts; (3) an online calendar on which you can post birthdays, anniversaries, and other special occasions; and (4) An online tickler system that reminds you of upcoming events.

3. You may cancel your Customer Monthly Subscription online or by submitting a written cancellation notice to SendOutCards at 1825 West Research Way, Salt Lake City Utah 84119. Cancellation notices must be received no later than 15 days prior to monthly standing order date in order to avoid the next month's charge.

4. If you cancel your monthly Subscription and have not purchased any products you may be subject to the phases of inactivity outlined in SendOutCards Policies and Procedures section 12.5. Once a Subscription is canceled a new monthly auto order may not be started for six (6) months. Any discounted point pricing will not be available to customers who are not on a monthly auto order. All autoship purchases are non-refundable beginning with the first purchase following the initial purchase.

5. Point expiration will take place at the end of the thirteenth month from date of purchase. Refer to Policies and Procedures for additional information.

NOTICE OF CANCELLATION

You may CANCEL the initial transaction, without any penalty or obligation, within THREE BUSINESS DAYS from the above date (five days for Alaska residents). Repeat purchases of the same product may be canceled only upon approval of SendOutCards.

If you cancel, any property traded in, any payments made by you under the contract or sale, and any negotiable instrument executed by you will be returned within TEN BUSINESS DAYS following receipt by the seller of your cancellation notice, and any security interest arising out of the transaction will be canceled.

If you cancel, you must make available to the seller at your residence, in substantially as good condition as when received, any goods delivered to you under this contract or sale; or you may if you wish, comply with the instructions of the seller regarding the return shipment of the goods at the seller's expense and risk.

If you do make the goods available to the seller and the seller does not pick them up within 20 days of the date of your notice of cancellation, you may retain or dispose of the goods without any further obligation. If you fail to make the goods available to the seller, or if you agree to return the goods to the seller and fail to do so, then you remain liable for performance of all obligations under the contract.
